c. **Amended Clause no. 6 (Earnest Money Deposit), Page no.9:**

6. Earnest Money Deposit

6.1. Earnest Money Deposit (EMD)/Bank Guarantee In Lieu Of EMD:

6.1.1. The bidder shall furnish Non interest earning Earnest Money Deposit (EMD) as specified in Bid details in brief description by way of Demand Draft drawn on any scheduled bank in favour of Canara Bank, payable at Bengaluru and should be kept along with the bid.

6.1.2. In case the EMD is submitted in the form of Bank Guarantee, the same should be valid for the minimum period of 6 months from the last date for submission of offer. The format for submission of EMD in the form of Bank Guarantee is as per ANNEXURE-8.

6.1.6. The EMD of bidders will be returned upon the finalization of Empanelment.

6.1.7. The EMD may be forfeited/ Bank Guarantee may be invoked, if the bidder withdraws or amends the bid during the period of bid validity which is six months from the last date for submission of offer.

6.2. Further, all bidders shall have to comply the following:



6.2.1. Failure to produce the documents as necessary proof along with the EMD while submission of EOI proposal shall render the applicant ineligible for empanelment.

6.2.2. The Bidder should not provide any commercial proposal with the response to this EOI.
