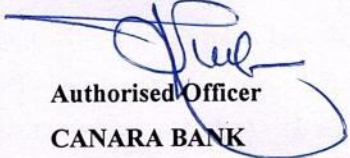
SPECIAL INSTRUCTION/CAUTION
