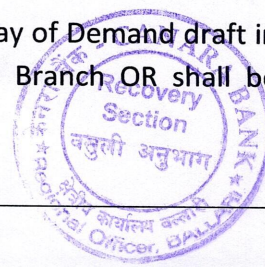

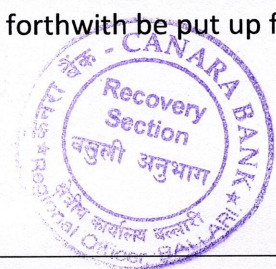
Other terms and conditions:
