

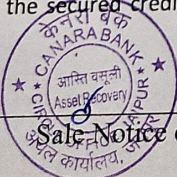
OTHER TERMS AND CONDITIONS:
