6. Other terms and conditions:

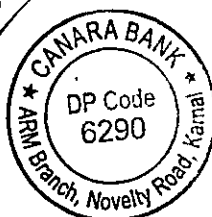


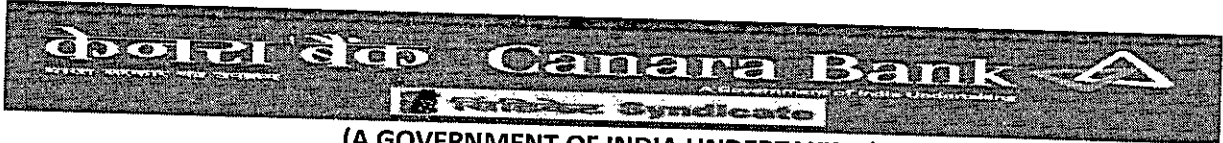
