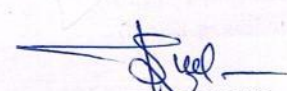

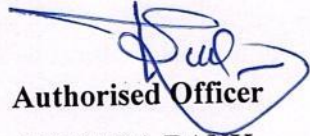
SPECIAL INSTRUCTION/CAUTION
