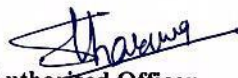

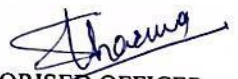

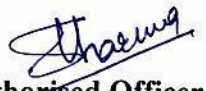
SPECIAL INSTRUCTION/CAUTION
