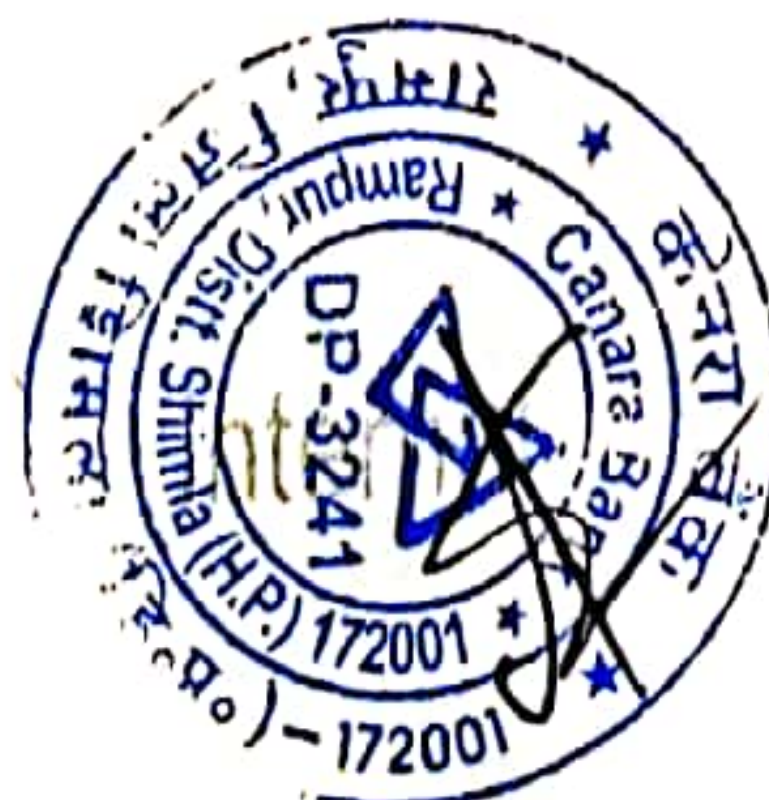

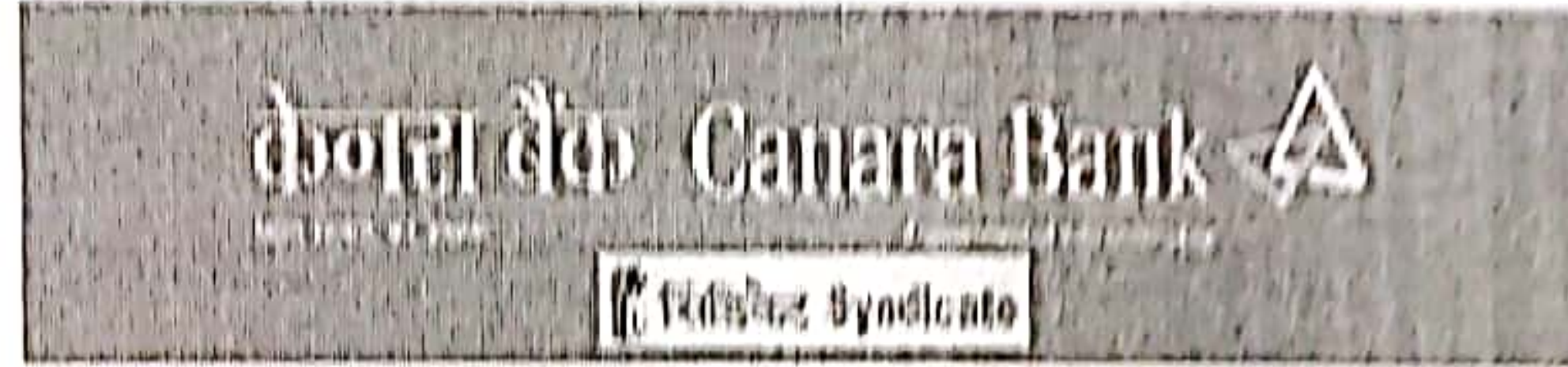


OTHER TERMS AND CONDITIONS
