SECTION F - OWNERSHIP & AWARDING OF CONTRACT

11. Pricing & Payments to the Selected Bidder.

- 11.1. No escalation in price quoted is permitted for any reason whatsoever. Prices quoted must be firm till the completion of the contract period.
- 11.2. From the date of placing the order till the delivery of the systems, if any changes are brought in the duties such as excise/customs etc., by the Government resulting in reduction of the cost of the systems, the benefit arising out of such reduction shall be passed on to the Bank
- 11.3. The selected bidder/s will be informed to quote the rentals for the below terminal types to be deployed. The rental will be fixed on mutual agreement with successful bidder.

13. Revenue Sharing to the Bank

- 13.1. The revenue share offered to the Bank must be as a percentage of the Net revenue earned (MDR+ Charges for VAS + Surcharge if any + Any Other revenue other than the monthly rent for POS machines interchange All network charges including assessment fee) exclusive of applicable GST and other taxes.
- 13.2. The agreed percentage of revenue has to be shared to bank on 15th of every month or 10 days from the date of submission of the invoice submitted for claiming rental charges of PoS
