- 2.2. Please note that Originals of invoices (plus One Copy) reflecting GST, GSTIN, State Code, HSN Code, State Name, Taxes & Duties, Proof of delivery duly signed by Bank officials of the respective Branch/office and Manufacturer's / Supplier's Warranty Certificate should be submitted while claiming payment in respect of orders placed.
- 2.3. Bank will release the payment on completion of activity and on production of relevant documents/invoices. Please note that Originals of invoices (plus One Copy) reflecting GST, GSTIN, State Code, HSN Code, State Name, Taxes & Duties, Proof of delivery duly signed by Bank officials of the respective Branch/office and Manufacturer's / Supplier's Warranty Certificate should be submitted while claiming payment in respect of orders placed.



- **2.4.** The selected bidder has to submit installation report/Sign off report duly signed by the Bank officials of the respective Branch/offices in originals while claiming payment. The invoice and installation report should contain the product serial number of the items supplied.
- **2.5.** Payment shall be released within 30 days from the date of submission of relevant documents as per GeM bid terms and found in order as per GeM bid terms.
- **2.6.** The bank shall finalize the installation and acceptance format mutually agreed by the selected bidder. The selected bidder shall strictly follow the mutually agreed format and submit the same for each location wise while claiming installation and acceptance payment.
- 2.7. The payments will be released through NEFT / RTGS after deducting the application LD/Penalty, TDS if any, by centrally by Head Office at Bengaluru and the selected bidder has to provide necessary Bank Details like Account No., Bank's Name with Branch, IFSC Code etc.

#### 3.5. Amended Penalties/Liquidated damages for not maintaining uptime:

**3.5.1.** If the selected bidder fails to maintain the guaranteed monthly uptime of <u>96.00%</u> for the Cash Recycler as specified in Annexure-9 (Scope of Work) and Annexure-10 (Technical and Functional requirements) during the contract period, the penalty for monthly Uptime will be deducted as under:

Level of availability calculated on monthly basis	Penalty Amount
96.00% and above	No penalty
94.00% to less than 96.00%	5% of quarterly payable amount for the machine.
92.00% to less than 94.00%	10% of quarterly payable amount for the machine.
90.00% to less than 92.00%	15% of quarterly payable amount for the machine.
Less than 90.00%	25% of quarterly payable amount for the machine.

- 3.5.2. The maximum penalty levied shall limited to 15% of Annual AMC cost.
- **3.5.3.** If monthly uptime is less than <u>90%</u>, the Bank shall levy penalty as above and shall have full right to terminate the contract under this GeM bid and invoke PBG. The right of termination shall be in addition to the penalty. The above penalty shall be deducted from any payments due to the selected bidder during contract period.
- **3.5.4.** If monthly uptime is less than <u>90%</u> in three consecutive months, bank may at its sole discretion blacklist the bidder in addition to imposing penalty and invoking the bank guarantee.

3.5.5. <u>During warranty period penalty shall be adjusted from the 10% remaining outstanding payment. During AMC period, penalty will be deducted from quarterly submitted invoice.</u>

#### 10. Amended Uptime

- 10.1. The selected bidder shall guarantee a 24\*7\*365 availability with monthly uptime of 96.00% for the Cash Recyclers as specified in Annexure-9 (Scope of Work) and Annexure-10 (Technical requirements), during contract period and also during AMC/ATS, if contracted, which shall be calculated on monthly basis.
- 10.2. The "Uptime" is, for calculation purposes, equals to the total contracted minutes in a month less Downtime. The "Downtime" is the time between the Time of Failure and Time of Restoration within the contracted minutes. "Failure" is the condition that renders the Bank unable to perform any of the defined functions on the Cash Recyclers. "Restoration" is the condition when the selected bidder demonstrates that the Cash Recycler is in working order and the Bank acknowledges the same.
- 10.3. The Downtime calculated shall not include any failure due to bank/ Non-availability of Network and down time during the time of preventive maintenance activity and Force Majeure. The bidder shall inform the Bank 7 days in advance before doing preventive maintenance or pre-planned activity.
- 10.4. The selected bidder should consider high-availability (active-passive) at DC & DR with RTO of 120 minutes.
- 10.5. Provide a robust, fault tolerant infrastructure with enterprise grade SLAs with an assured uptime of <u>96.00%</u>.
- 10.6.If the selected bidder is not able to attend the troubleshooting calls on solution/product working due to closure of the office/non-availability of access to the solution/product, the response time/uptime will be taken from the opening of the office for the purpose of uptime calculation. The selected bidder shall provide the monthly uptime reports during contract period.
- **10.7.** The downtime calculated shall not include any failure due to bank, third party and Force Majeure.
- 10.8. The percentage uptime is calculated on monthly basis as follows:

- 10.9. Contracted hours of a month = No. of days in that month \* 24.
- 10.10. The Downtime calculated shall not include any failure due to Bank and Force Majeure.
