Sandel: Need for new paradigm on meritocracy

New Delhi: Renowned po-

litical philosopher Mi-

chael Sandel has said that there is a need to shift political discourse away from arming people for meritocratic competition, to being more inclusive and more attentive to inequalities of social recognition and esteem. Outlining how this "tyranny of merit" or the widening divide between winners and losers over the last four decades has, in general, impacted and "poisoned" politics, Sandel stressed that the solution lies in politically putting greater emphasis on dignity of work and an alternative way of thinking about success.

In an exclusive interview to Times Now, Sandel also posited the possibility of pluralistic ways of allowing communities to give expression to their history, traditions and identities that resist polarising tendencies. "I find civilizational turn of public discourse in India fascinating and wonder whether a purely secular political project can sustain itself without finding a way to tap into rooted traditions of a culture and of a civilization", he added.

Dwelling on the debate of hypernationalism versus liberals, the philosopher pointed out that "fundamentalists and hyper nationalists rush in to fill a void where liberals fear to tread, where there is such a thoroughly emptied public space that it creates a backlash". He added that this was why he felt it was necessary to

find ways to bring into public discourse, "in a healthy, pluralistic way, expressions of identities and traditions and moral and religious convictions... because otherwise, the backlash will come with a kind of insistence that can lead to intolerance and that can lead to the majority imposing on the minority."

rent version of market-

driven meritocracy has

produced a kind of hubris among winners, Sandel pointed out, "In American context, the sense among many working people that elites look down on them, has fueled the backlash against elites that we saw with the election of Donald Trump in 2016". He added that this "politics of grievance speaks to people's sense, especially working people's sense, that credentialed meritocratic elites are looking down on them — and that's why I think it's important to diagnose the dark side of meritocracy, its corrosive effect on solidarity in common good, along with the very important advantages of meritocracy."

TOI that all existing criminal cases as well as new ones to be registered before said date under IPC, CrPC and Evidence Act shall be tried as per provisions of old laws.

BNS, BNSS and BSA were passed by Parliament on Dec 21, 2023 and received presidential assent on Dec 25. According to home minister Amit Shah, once the three criminal laws are fully implemented, Indian criminal justice system will be among world's most modern, with disposal of a criminal case taking no more than three years.

Importantly, while BNSS provides for mandatory forensic examination of the crime scene in offences punishable with seven years or more, this need not uniformly kick in across the country from July 1. Section 176(3) of BNSS has a built-in breather of five years for states that are yet to build up their respective forensic capabilities. The provision states that a police officer in charge of a police station, shall, from such date as may be notified within a period of five years by state govt, cause forensic experts to visit a crime scene to collect evidence and also cause

videography of the process on a mobile phone or any other electronic device.

A source told TOI that while states can decide own timelines on forensics, which may be "as early as possible but not later than five years", videography of the crime scene and storing of digital evidence may be possible from July 1 as relevant technical systems are being readied to maintain the "chain of custody".

As regards BSA, sources said much ground has been covered, including on issue of digital summons through ecourts software. This facility was recently tested in Madhya Pradesh and top judiciary is on board for its national rollout.

Sources said all cases registered under BNS will need to follow timelines prescribed by BNSS for various criminal procedures. This means an FIR filed electronically must be taken on record in three days, investigation status shared with victim or informant within 90 days and charges framed by the magistrate within 60 days from supply of chargesheet. Importantly, judgment should be declared within 45 days of conclusion of trial, and acquittal or conviction decided upon by the sessions court within 30 days after completion or arguments (extendable up to 45 days). The courts will have to

accordingly develop capacity.

Truckers welcome move to put hit-and-run penalty provision in abeyance

New Delhi: Truckers and transporters have welcomed

govt putting the implementation of Section 106(2) of Bharatiya Nyay Sanhita in abeyance even as all other provisions of the three criminal laws will come into force from July 1.

"Govt has kept its commitment to AIMTC, drivers, truckers and the transport fraternity by refraining from implementing the contentious Section 106(2) of BNS. The decision is a significant relief to entire transportation sector. This clause has been a subject of concern and debate within the industry due to its potential implications on operations and compliance," chairman of All India Motor Transport Congress (AIMTC) Bal Malkit Singh said.

The All India Transporters Welfare Association said, "This issue had caused a nationwide stir amongst the truck driver community in Dec 2023 to Jan 2024. It is important to understand difficulties faced by truck drivers who are tirelessly working to keep our supply chains robust. The conditions on highways are stressful and demanding." The Bus and Car Operators Confederation of India has also welcomed the decision. TNN


