3. The last date for accepting the offers in sealed covers is 24.06.2024 up to 03.00PM. Offers received on or before the stipulated date and accompanied by requisite EARNEST MONEY DEPOSIT will only be considered. TENDERS WILL BE OPENED AT 03.30 PM ON 24.06.2024 at Canara Bank Circle Office building P B No.14, Vipin Khand, Gomti Nagar, Lucknow-226010.
4. The EARNEST MONEY DEPOSIT will be refunded to the unsuccessful offerors. No interest shall be payable on the EMD. THE OFFER ONCE MADE SHALL BE IRREVOCABLE.
5. In case of acceptance of the offer by the Bank, the EMD shall be adjusted against the total price offered by the successful offeror subject to payment of the balance before the stipulated date.
6. The acceptance of the offer will be intimated to the successful offeror /notified on the Notice Board at the Circle Office and such notice shall be deemed to be personal notice of information to the successful offeror and shall be binding on him.
7. The successful offeror shall pay the balance amount forthwith on the day on which the acceptance of the offer is notified/within the time limit permitted.

12. The Bank reserves the right to reject any offer without giving any reasons thereof. The bank shall not be responsible for any loss, damage decay, and theft or removal of parts from it or in any manner whatsoever.

The bank shall have the option and liberty to sell the vehicle in case of the purchaser's failure to take delivery within the stipulated period after issuing a notice to the purchaser's given address. After a period of 15 days from issue of notice the Bank shall be entitled to exercise its option to resell the vehicle.
14. However the purchaser shall have no right or claim whatsoever against the Bank after the period mentioned above on account of his failure to take delivery or bank is bound to resell the vehicle or bank will not be answerable in any manner for any loss that he may incur on this account.
