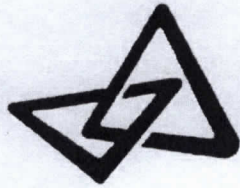

NOTICE FOR EMPANELMENT

Premises & Estate Section of Canara Bank, Circle office Ranchi is managing Bank's branches/office premises at various locations of the state of Jharkhand. The intention of this notice of empanelment is to maintain a separate panel of various contractors/vendors/suppliers/firms under various categories for various types of works as and when required by the bank. The Last date for submission of applications is 28.03.2022

Note: The panel will only be valid for the state of Jharkhand unless any other specific orders given by the Bank.

GENERAL RULES AND INSTRUCTIONS TO THE INTENDING APPLICANTS

1. Generally, the routine works of the Bank are awarded/procurements are made by calling competitive tenders/quotations from the empanelled contractors/ suppliers and in case of emergent works/ works of small magnitude, the Bank may opt to award the work/procure supply from any of the empanelled agencies, depending on the exigencies of the work on nomination basis and also has the right for open tendering process for any particular work, depending on the nature & magnitude of the work.
2. The details of the applicants and their experience shall be furnished in the prescribed "Application Format" only. Wherever required and if the space provided is not sufficient, particulars can be furnished in Annexures but such details shall be clearly mentioned in the respective columns of the Application Format. Applicant shall enclose latest copies of brochures and technical documentation giving additional information about the applicant. Each page of the document shall be duly signed by the Applicant or their authorized representative.
3. No costs incurred by the applicant in applying, in providing necessary clarifications or attending discussions, conferences or site visits will be reimbursed by the Bank.
4. Documentary proof with respect to the prequalification criteria shall be furnished along with the application form. In this regard, copies of the work orders and completion certificates and or such other documents shall be submitted. Incomplete applications or applications without proper proofs for establishing their credentials will be liable for rejection and no correspondence will be entertained in this regard.
5. The authorized person of the firm/ company shall sign in all the pages of the application with seal of the company/ firm.
6. The empanelment will be made for a specific category depending on the credentials submitted. However, the applicant empanelled in higher category shall be eligible for works in the lower category.
7. The evaluation will be based on the experience, reputation, empanelment with other Banks, PSUs, Govt institutions, manpower & logistical support of the applicant, their financial capabilities, quality consciousness, etc and if found necessary may also include inspecting the works undertaken by them for which, necessary co-ordination shall be made by them. Based on the details furnished and inspection of works, eligibility criteria, the applicants will be empanelled. Decision of the Bank regarding selection / rejection for empanelment will be final and binding and no further correspondence will be entertained. The empanelled contractors will only be informed by post.
8. If the information and details furnished by applicants are found to be false at any time in future or any information withheld, which comes to the notice of the Bank at a later date, the empanelment of such applicant will be cancelled immediately.
9. Applications received after the due date and time are liable for rejections.
10. **The Applicants must have their office in the geographical jurisdiction of the State of Jharkhand. The empanelment shall be valid for a period of one year w.ef 01.04.2022 i.e till 31.03.2023.**
11. The present empanelment is mainly for works for value upto the limits mentioned in respective categories. In case of any high value works, Bank may undertake the works by project specific pre-qualification exercise.

SCOPE OF THE WORKS**1. Civil Engineering works**

The broad scope of work of Civil Contractors is to undertake new constructions, redevelopment of existing properties, periodical repairs & renovations, painting, plumbing & sanitary, demolition works, structural steel fabrication, wood work (doors and windows only) waterproofing works of terrace, lift well, toilets etc. and other allied works for residences and offices of the Bank.

2. Interior Furnishing / Modular Furnishing

The scope of work of Contractors for Interior works mainly include original works, alterations and renovations of the branch premises involving erection of partitions work both wood & aluminum, counters, paneling, false ceiling, cavity flooring, storage units, furniture and fabricated workstations and other allied furnishing works.

3. Electrical Contractors

The scope of work for Electrical Contractors is to undertake HT as well LT works, panel board for LT applications, will be mainly used for internal and external electrification, associated cabling, copper plate earthing, wiring for air-conditioners, UPS, liasoning with JSEB for obtention of additional power, breakdown repair, interior wiring for computerized office environment and other allied works. The electrical works also involves domestic electrical works attending to LT side, liasoning with JSEB in case of meter burnouts etc. attending to repairs of electrical appliances like fans, geysers, pumps & motors, switch boards, re-wiring and cabling works. Exposure to repairs of other appliances like fridge, mixers, washing machines etc. will be added advantage. Electrical contractors shall have necessary permits / license from Chief Electrical Inspector of Jharkhand (CEIJ) office and familiar with IE rules & regulations and guidelines of CEIJ.

4. Air conditioning equipments supplier (including maintenance)

The Air-conditioner units suppliers shall be the manufacturers/ suppliers/service providers of window units, split units, ductable split, package air-conditioners and should be direct dealer and have good service network in the Ranchi city and in other major districts of Jharkhand state.

5. Supply and fixing of Glow Sign Board

The scope of work includes supply, Installation and maintenance of Glow Sign Board, Non Lit Boards, Name Boards and various other Bank Signage as required from time to time. They should have qualified artwork designing team. The vendor should have sufficient knowledge in Sign board area, quality product and having good skills workers in this field.

6. Supply of UPS / Battery

Supplier shall have necessary and valid permits / license of Branded UPS / Battery preferable Exide and other reputed makes and ready to supply and install the item in all our branches in the areas of Jharkhand State without additional / differential freight charges.

7. Supply of Security Gadgets such as Fire Alarm System, Burglar Alarm, System, Auto Dialer, Fire Extinguisher, CCTV

The scope of work for Contractors of the Fire detection and alarm System, Burglar Alarm System, Auto Dialer System, Fire Extinguishers and CCTV etc (as applicable) mainly involves all original works, alterations and modifications involving supply, installation, testing and commissioning for branches /chests/ATMs/offices of our Bank. The suppliers should have minimum experience of 3 years experience in supplying various type of Fire detection and alarm System / Burglar Alarm System /Auto Dialer System / Fire Extinguishers / DVR CCTV system/NVR CCTV System/ equipments with different Capacity to Government Departments / Public Sector Undertaking /Public Sector Banks/ Central Autonomous Bodies / State Autonomous Bodies / Financial Institutions or other reputed firms and large Offices. Also the suppliers should have sufficient staff and satisfactory experience in maintenance of all type of such Security equipment systems as applicable. If Banks requires imported Security items then the vendor should have the direct dealership of the products which need to be supplied.

8. Providing Private Security Agency (PSA) Services, for providing security guards in our branches/offices/chests/ATMs

The scope of work for PSAs include providing guarding arrangement (Armed and Un-armed guards) at our branches/offices/chests/ATMs in the state of Jharkhand. The suppliers should have minimum experience of 3 years experience in providing guarding arrangement to Government Departments / Public Sector Undertaking /Public Sector Banks/ Central Autonomous Bodies / State Autonomous Bodies / Financial Institutions or other reputed firms and large Offices. Also the suppliers should have sufficient staff.

9. Courier Services

Courier Service Provider should have office in the geographical Jurisdiction of Ranchi City and good service network in Urban, Semi urban and Rural areas of Jharkhand state. They should have all India presence. Proof of address with copy of lease agreement for proof of ownership should be attached in support of this. The Courier agency should have provided satisfactory service in the respective region to any of the Scheduled Banks / Financial institutions / Government Departments having all India network etc. Order copies OR Satisfactory certificate from the clients with number years of service should be attached. The Courier Agency should have the facility of Web tracking of the Courier / Consignments.

10. Note Counting Machine Machines & UV Lamps

They should have minimum of 3 years experience in the activity of supply and maintenance of currency Note Authenticator / Note Counting / Note Sorting Machines capable of detecting suspected counterfeit notes as per latest RBI guidelines. The Model quoted by the supplier should have been released / operational in the market for at least 12 months.
