

- 9. The acceptance of the offer will be intimated to the successful offeror/notified on the bank's website and such notice shall be deemed to be personal notice of information to the successful offeror and shall be binding on him.
- 10. The successful offeror shall pay the balance amount forthwith on the day on which the acceptance of the offer is notified/within the time limit permitted.

- 12.
