

- 8. All the submitted offers shall be opened at CANARA BANK, Circle Office, East Veli Street, St Mary's Campus, Madurai 625001 on 17.04.2023, 4.00PM.
- 9. The offer once made shall be irrevocable.
- 10. The EMD amount shall be refunded to the unsuccessful bidders. NO interest shall be payable on the EMD Amount.
